**RESOLUTION REQUESTING THE OWNERS OF POULTRY AND PIGGERY FARMS IN THE CITY OF NAGA NOT TO REPLACE ITS STOCKS AFTER HARVEST OF PRESENT STOCK WITHOUT COMPLIANCE WITH ALL THE NECESSARY REQUIREMENTS SPECIFIED UNDER EXISTING ORDINANCES ON SANITATION AND BUILDING CODE, AND FURTHER DIRECTING THE CITY HEALTH OFFICE TO MONITOR THE STRICT COMPLIANCE THEREOF:-**

**WHEREAS,** received by the Sangguniang Panlungsod for appropriate action is the letter dated July 8, 2016 of Mr. Gerson D. Ramirez, Dean of Student Services, Naga View Adventist College, Inc., forwarding the resolution petitioning the closure of the Magtoto's Piggery and Poultry Farm which is located around 400 meters south of Naga View Adventist College Campus, Barangay Panicuason, this city;

**WHEREAS,** the 12<sup>th</sup> Sangguniang Panlungsod concurs with the sentiments of students, parents, officers, faculty and staff of Naga View Adventist College, Inc. that the existence of the said piggery and poultry farms threatens the health of the people in the community due to its foul odor and improper waste management disposal;

**WHEREAS,** finding the same to be in order;

**NOW, THEREFORE,** on motion of Hon. Julian C. Lavadia Jr., seconded by Hon. Cecilia Veluz-De Asis, Hon. Mila S.D. Raquid-Arroyo and Hon. Joselito S.A. del Rosario;

**BE IT RESOLVED,** as it is hereby resolved, to request the owners of poultry and piggery farms in the City of Naga NOT to replace its stocks after harvest of present stock without compliance with all the necessary requirements specified under existing ordinances on sanitation and building code;

**BE IT RESOLVED FURTHER,** as it is further resolved, to direct the City Health Office to monitor the strict compliance of this resolution.

**LET COPIES** of this resolution be furnished His Honor, the City Mayor for his concurrence, all owners of poultry and piggery farms for their information and favorable consideration, the Environmental Management Bureau for its information, the City Engineer, the City Planning & Development Officer, the City Health Officer, the City ENRO, the City Treasurer, the City Veterinarian and the City Health Officer, for their information and guidance.
